REPRESENTATIVE MATTERS

- Defended a City against allegations that a police officer owed a duty to protect a pedestrian who was seriously injured in a traffic accident. This trial resulted in a defense verdict.
- Drafted the appellate briefs and argued *Martinez v. City of Beverly Hills* (2021) 71 Cal.App.5th 508, which created a lower standard of constructive notice for areas of public property not commonly used by pedestrians.
