REPRESENTATIVE MATTERS

- Second chaired jury trial between major retailer and developer involving disputes over proposed further development in a power shopping center to intensify uses, and in defense of claims over use of common areas. Successfully obtained a temporary restraining order and preliminary injunction based on evidence of impacts to visibility, parking, and access. In the middle of jury trial, opposing party abandoned all claims and agreed not to pursue further development or alterations.
- First chaired a court trial to successfully obtain restraining orders and an award of attorneys' fees to protect business interests of a Fortune 500 Company client.
- Represented public utility in eminent domain actions to acquire easements for gas transmission lines.
- Represented public entity in eminent domain action to acquire fee interests, easements, temporary construction easements, and other associated rights for bridge expansion project.
- Represented private landowners and a residential subdivision developer in litigation with neighboring homeowners' association over entitlement to road and utility access through HOA to a main highway, requiring interpretation of aged development agreement and CEQA documentation. Obtained settlement establishing easements for all required access and recompense for millions of dollars in damages caused by delay.
