#### What Is Class Action Litigation?

A class action lawsuit often entails one person or a small group of people prosecuting a lawsuit on behalf of a larger group of people who have all purportedly suffered similar injury from an in common defendant. The settlement or judgment of the lawsuit applies to all members of the court-approved 'class' and blocks other members from filing their own cases. Class actions can be brought in federal court or in state courts depending on the basis for the claim.

We litigate and try cases in nearly every combination of venues, including state and federal trial and appellate courts.

A putative class action in a multi-claimant lawsuit where the purported injured class has not yet been certified by a court. Burke Class Action litigation attorneys routinely defend putative class actions for both private and public sector clients.

### Private Attorney General Class Action (PAGA) Defense

The Private Attorneys General Act of 2004 is a California statute that authorizes purportedly aggrieved employees to bring actions for civil penalties on behalf of themselves, their workplace colleagues, and the State of California against their employers for California Labor Code violations. Burke Class Action attorneys have successfully defended both public and private employers from PAGA class actions. We have defeated class certification in many putative class actions, including defeating class certification in two multi-public agency cases.
